Documents required: Confirmation of warrant cancellation/ release, relevant customs documentation, instructions and the confirmation of a mutual contract relationship including acceptance of our local General Terms and Conditions, everything needs to be in place prior to outbound delivery

Handling: Loading dates/times need to be mutually agreed in advance. In case of FOT deliveries please be guided that truck details (license plate of truck and trailer as well as driver's name) need to be advised latest 12h00 AM of the previous working day, once the outbound delivery has been mutually agreed.

Operational hours: Monday – Friday 07h00 – 15h00, Holidays excluded.

Payment of all outstanding costs incl. warehouse rents need to be effected prior to delivery.
